The Building Contractor is advised that:

1. All out of hours work is to be done;
 - (a) using the quietest reasonably available equipment; and
 - (b) according to Australian Standard 2436-2010, guide to noise and vibration control on construction, demolition and maintenance sites.
2. The playing of radios is not permitted out of hours.
3. Use of vehicular reversing sirens to be minimised or eliminated where practicable.
4. A detailed Noise Management Plan including map detailing the location of the construction area is to be appended to this document which is to fully address the requirements of Regulation 13 of the Environmental Protection (Noise) Regulations 1997.
5. All works carried out on Sundays and W.A. Public Holidays to use low noise and dust impact equipment at the greatest distance possible from noise sensitive premises (residential properties) i.e. at least 200m and no piling equipment, bulldozers, compactors, cranes, dump trucks, graders, loaders, scrapers, pneumatic concrete breaking tools or explosive powered tools etc.
6. No works to be carried out at all on:
 - Anzac Day
 - Christmas Day
 - Boxing Day
 - New Year's Day
7. Failure to adhere to this Noise Management Plan renders Regulation 13 of the Environmental Protection (Noise) Regulations 1997 inapplicable, in which case the noise emissions must meet Regulations 7 and 8 of those Regulations.
